Uses

Emer-Clad Fabric Reinforcing Tape is a non woven fabric designed for use with liquid membrane and high build coating products for enhancing reinforcement, tensile strength and uniform layers in liquid membrane applications. This fabric has been designed to easily wet into high build liquid membranes, preventing the creasing and wrinkle phenomena often found with general glass fibre and other reinforcement matting materials. Suitable for both vertical and horizontal applications, the tape displays outstanding workability and provides excellent rupture and rot resistance.

Advantages

- Excellent resistance to detergents, bleaches, chemicals and water
- Ease of use with liquid membranes, preventing wrinkling and excessive creasing
- Rot resistant, suitable in wet areas, external areas, underground and immersed areas
- Durable when reinforced within liquid coating
- Conforms well to substrate surfaces, returns and abutments
- Light weight
- Material weight – 40g/m²

Application Instructions

Product can be cut with scissors, knife or similar cutting tools.

Apply a generous coating of the liquid membrane being used to the substrate where the reinforcing tape is to be applied and while in a wet state embed the fabric into position. Do not allow liquid membrane to tack off or skin before embedding fabric.

Air pockets or creases formed should be removed with a flat spatula or brush when the membrane is in a wet state. Overlap the tape a minimum of 30mm where required.

Subsequent coats of the liquid membrane should ensure the total fabric is covered and fully encapsulated.
